

Containerized BESS project financing options in Oman 2026

Will Oman have a solar energy storage system?

Additionally, PDO is finalizing plans for a 100 MW solar PV-based IPP, named the 'North Solar Storage IPP,' set to include Oman's first battery energy storage system (BESS). This BESS, using lithium-ion battery technology, will store electrical energy and supply a maximum of 100 MW peak power to PDO's grid during daylight hours.

Which MENA region will be a Bess market in 2026?

The rapid growth rate of energy storage in the MENA region, led by the GCC, is surprising many analysts. Saudi Arabia, in particular, is set to be the third biggest global BESS market after the USA and China in 2026.

How does Bess procurement work in the UAE?

In the UAE, Emirates Water and Electricity Company (EWEC) issued in July 2024 a RfP for a 400 MW /400 MWh standalone BESS project. These offtakers conduct BESS procurement either through the EPC route, where they procure the BESS product, or via the IFP route, where they procure flexibility services.

What is the global Bess capacity in 2023?

As per the International Energy Agency (IEA), global BESS capacity was 85 GW (approximately 190 GWh) at the end of 2023 and is expected to reach 400 GW (over 1,200 GWh) by 2030 to enable the seamless grid integration of renewable energy, with the net zero 2050 emissions scenario as a target.

What are the benefits of Bess in the MENA region?

The universal benefits of BESS apply just as strongly to the MENA region: they can support in harnessing the full potential of renewable energy by storing & shifting record low-cost PV or wind power generation to times of the day when demand for electricity is at its highest.

Is blended financing a viable financial model for Bess projects?

As per McKinsey & Company, the market size of the BESS ecosystem is expected to reach \$150 billion by 2030. Thus, blended financing as a financial model should be considered, where public capital can be used as a first-loss capital for BESS projects. This offers private financiers the comfort of providing capital at a competitive rate.
