What is employment income in Cyprus?

Employment income in Cyprus includes income arising under a contract of employment and the income of office holders, such as directors. This is compulsory and covers all individuals working in Cyprus (employed and self-employed). The payments are made by three parties: the employer, the employee, and the state.

What is a PAYE tax in Cyprus?

The PAYE (Pay As You Earn) is the system used by the Cyprus Tax Authorities to collect Income Tax contributions that arise from employment provisions. It is a withholding tax, deducted from the employee's gross emoluments, and applies to all emoluments, wages, directors' emolument, pensions, and benefits in kind.

What contributions will I be liable to if I work in Cyprus?

You will be liable to contributions to the Redundancy Fund (1.2%) and the Human Resource Development fund (0.5%) for all employees. The PAYE (Pay As You Earn) system is used by the Cyprus Tax Authorities to collect Income Tax contributions that arise from employment provisions.
