

Government procurement price of BESS in Sweden

What is the public procurement system like in Sweden?

Sweden is characterised by a high performing public procurement system, which is fairly advanced in its strategic dimension, including green, innovation and social criteria. Also, it remains quite dispersed and decentralised, despite the presence of national organisations for public procurement.

Who oversees public procurement in Sweden?

Oversight of public procurement is also carried out by the National Audit Office (NAO). As the highest authority for supervising public spending in Sweden, it performs external controls of regulatory compliance and provides Parliament with information and recommendations.

Does BESS work in the Swedish electrical infrastructure?

The last part of the literature study was devoted to the implementation of BESS in the Swedish electrical infrastructure, where regulations and permits were examined surrounding BESS implementation. Then, information about the factors one must consider when doing a BESS project or wants to construct a BESS site.

How much does a BESS cost per year?

Dividing the CAPEX over the lifetime of 20 years for the BESS and adding the annual OPEX costs gives the total cost for service per year. The result for cost-of-service ranges from 5.4 MSEK to 5.8 MSEK per year for a BESS at the Eon north NDN13L tariff (130 kV connection).

6. Conclusion In recent years, the cost of FCR-N procurement in Sweden has been progressively on the rise while the balancing market has largely been dependent on hydropower plants and hydrological conditions.

How much does it cost to build a BESS site?

In general, the largest cost in building a BESS site is the battery container making up approximately 50 % of the CAPEX. The CAPEX price of the whole site and system for stationary applications i.e., Li-ion BESS have been presented by the European Commission in 2020 to be around 350-450 EUR/kWh.
