What is public procurement system in Tanzania?

Public procurement system in Tanzania is decentralized, meaning that all entities covered by the law conduct public procurement activities individually through means available in the country. Centralized procurement is also allowed via the framework agreements.

How can I access Tanzania's Open and transparent procurement data?

Access Tanzania's open and transparent procurement data, sourced in real-time from the official Tanzania Electronic Procurement System (NeST). This portal delivers OCDS-compliant information on contracts and awards, enabling data-driven analysis and strengthening public accountability. Select the card to view, filter or download the data.

Is corruption in procurement a serious problem in Zanzibar?

However, reports obtained from the Zanzibar Anti-Corruption and Economic Crimes Authority (ZAECA), shows that corruption in procurement and contract management is not a very serious problem. Of all cases of corruption reported to ZAECA for 2019, only 2.6% related to procurement and contract management.
