Who determines the procurement procedure in Turkey?

In Turkish procurement legislation, the determination of the procurement procedure is the duty of the "contracting officer" on behalf of the contracting authority. In order to increase competition and participation in tendering, one of the "basic tender procedure", namely the "open procedure" and the "restricted procedure", should be selected.

What is the electronic public procurement platform (ekap)?

In addition, the Electronic Public Procurement Platform (EKAP) makes it possible to publish tender notices and tenders, enabling more tenderers to participate in tenders. Through the EKAP, the public is informed about the use of public resources.

What are non-price factors in Turkish procurement?

In the Turkish procurement system, offers may also be evaluated on the basis of "non-price factors", provided that these are specified in the procurement document. In this case, an assessment can be made by considering factors other than price, such as operation and maintenance cost, cost effectiveness, productivity, quality and technical value.

How are public procurement tenders regulated?

Such tenders are regulated in Public Procurement Law No. 4734, which entered into force in 2002.

What are the rules governing tenders in Turkey?

Distinct laws govern tenders that generate revenue for the state and those that incur expenses to the state in the Turkish procurement system. Tenders generating revenue for the state are regulated under the State Procurement Law No. 2886. Such tenders may include the sale and leasing of movable and immovable property belonging to the state.
