How much is a feed-in tariff for a solar project in Greece?

The new law has also put an end to feed-in tariffs for solar projects up to 500 kW in size. Developers of such installations with the necessary licenses can sign contracts with Greece's Renewable Energy Sources Operator and sell the generated electricity in the electricity market at a feed-in tariff of EUR65.73 (\$71.37)/MWh.

How much a storage system is subsidized?

In both cases, only the storage system is subsidized. The size of the subsidy depends on the company submitting the application - the number of its employees and annual turnover. It is set at 30% of the system cost for large companies, 40% for medium-sized companies, and 50% for small companies.
