

# Government procurement price of gel battery storage in Mexico

How are GOM procurement and contracts governed in Mexico?

GOM procurement and contracts are governed by Article 134 of the Mexican Constitution, the Public Procurement Act (Ley de Adquisiciones, Arrendamientos y Servicios del Sector Público or LAASSP), and the Public Works Act (Ley de Obras Públicas y Servicios Relacionados con las Mismas or LOPSRM).
