What types of energy providers are eligible for a secondary procurement process?

Installation for distributed and embedded energy generation (eg solar panel installation). Energy audits or external energy management advice or software. Liquefied petroleum gas (LPG) and natural gas providers. Eligible agencies and schools are required to join the secondary procurement process (SPP).

What are the government procurement rules?

They are the good practice standards for government procurement, and were last substantially revised in March 2015. The Rules apply to all public service departments, police, defence force and state services agencies, with a number of other central and local government agencies expected or encouraged to have regard to the Rules.

Can a grid-scale battery ESS offer generation reserve?

A grid-scale battery ESS is already able to participate fully in the energy market, however it cannot offer generation reserve. This is because the Code defines which specific technologies can offer instantaneous reserve and those definitions were written before ESSs were contemplated.

What is public value in procurement?

This expectation should be communicated clearly and early to suppliers. Public value means using resources economically and considering the net benefits of a procurement, its contribution to specific results and broader outcomes for New Zealand.
