

# Residential ESS project financing options in Spain 2026

How many home renovation projects in Spain will be financed by PRTR?

Well, about EUR3.42 billion have been set aside to fund the PRTR from 2022 until 2026 with the aim of facilitating 510,000 home renovations and rehabilitations. In other words, the government wants to almost multiply by 10 the home renovation projects in Spain.

How will the European Commission support large-scale energy storage in Spain?

The European Commission on Monday approved a new aid scheme for the deployment of large-scale electricity storage in Spain. Subsidies will be available for standalone energy storage sites, projects installed alongside renewable energy facilities, and storage planned as part of thermal power plants.

Any property in Spain can be eligible for home renovation subsidies using NextGenerationEU funding, providing the works lead to a reduction in energy consumption. Will Spain get 20GW of new energy storage by 2030?

Spain is targeting 20GW of new energy storage by 2030. MITECO also launched a similarly-sized grant scheme specifically for co-located or hybridised energy storage projects, for which proposals were due in March 2023. Enel Green Power submitted two projects during the first quarter which fit the criteria, totalling 60MWh and 38MWh respectively.
