

# Rooftop solar storage tender price in Netherlands 2025

How many bids did Germany get for rooftop solar PV projects?

Analysis of the latest European PV tenders Germany's Federal Network Agency (Bundesnetzagentur) said the country had awarded 119 bids for 259MW of rooftop solar PV projects in the latest government tender. Like several previous tenders in Germany, the rooftop solar tender was oversubscribed by 1.7 times.

When is the next rooftop solar tender?

The next tender for rooftop solar PV systems will be held on February 1, 2025. France awards 253 MW of rooftop solar projects Neighboring France awarded 253 MW of rooftop solar projects in its latest tender. The eighth rooftop solar tender awarded 72 projects at an average price of EUR99.95/MWh (about \$105.2/MWh).

What is the largest solar market in the Netherlands?

In 2022, the largest market segment in the Netherlands was the residential rooftop market, with a 46% share (about 1.8 GW) of the total market. The commercial rooftop market accounted for a 30% share (about 1.3 GW), while the ground-mounted and floating solar PV market accounted for 24% (about 0.9 GW).

What is the market outlook for solar power in the Netherlands?

According to the Global Market Outlook for Solar Power report, the market in the Netherlands is developing strongly, with an addition of 3.9 GW of solar PV capacity in 2022 and a project programme already approved for 11 GW.

How many times has the rooftop solar tender been oversubscribed?

Like several previous tenders in Germany, the rooftop solar tender was oversubscribed by 1.7 times. According to the Federal Network Agency, a total of 209 bids were submitted for a total capacity of 434MW, setting a record for rooftop solar tenders.

How much does a rooftop solar project cost in France?

Neighboring France awarded 253 MW of rooftop solar projects in its latest tender. The eighth rooftop solar tender awarded 72 projects at an average price of EUR99.95/MWh (about \$105.2/MWh). This was nearly EUR2 lower than the average price of the seventh tender held in July.
